

OFFICIAL TOYOTA TRICK SHOT CONTEST RULES

NO PURCHASE NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT INCREASE YOUR ODDS OF WINNING. ALL FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

ELIGIBILITY. Promotion open to individuals that are legal Oregon or SW Washington residents that have a U.S. driver license, and are 21 years of age and older at the time of entry, except employees (former and current), agents, successors and assignees of Portland Winterhawks, Inc., Toyota Motor Sales U.S.A., Inc., the Pacific Northwest Toyota Dealers Association, SCA Promotions Inc., the Western Hockey League and its Member Teams, and each of their respective affiliated companies, subsidiaries, and advertising or promotional agencies (together, the "Contest Entities"), and the family members of, agents, successors, or assigns of, and any persons domiciled with, such employees are not eligible for entry. The following are also not eligible to enter: (A) Current or former professional or semi-professional hockey players or coaches; (B) College Varsity hockey players or coaches who have played or coached at that level in the past five (5) years; (C) Junior A (Major or Minor), B or C hockey players or coaches who have played or coached at that level in the past five (5) years; (D) Contestants who have played on organized, recreational-league hockey teams in the past five (5) years; and (E) persons who have been chosen as a previous contestant in this puck shoot promotion during the past 12 months.

ENTRY. Toyota Trick Shot (the "Promotion") will begin at 12:01 am prevailing Pacific Time on Friday October 25th, 2025, and all entries must be received by 12:01 p.m. prevailing Pacific Time on Friday, March 21, 2026 (the "Promotion Period"). Limit one entry per person. To enter, visit the Toyota Trick Shot official registration page on the winterhawks.com website and complete all of the required information, and follow all instructions. Submit your entry by clicking on the "SEND" button. You must complete the entire form in order to enter the Promotion online or in person at a Winterhawks Home game or promotional appearance in conjunction with Toyota. Portland Winterhawks, Inc. ("Sponsor") and the Pacific Northwest Toyota Dealers Association ("Prize Provider") will not be responsible for incomplete, lost, late, postage-due, misdirected or illegible entries, or for failure to receive entries due to transmission failures or technical failures of any kind, including, without limitation, malfunctioning of any network, hardware or software, whether originating with sender or Sponsor or Prize Provider. In the event of a dispute, all e-mail entries will be deemed to have been submitted by the owner of the e-mail account from which they were sent. For these purposes, an email account holder shall mean the natural person assigned to such email account by the Internet access provider, online service provider or other organization responsible for assigning e-mail addresses for the domain associated with such e-mail account. Any questions regarding the number of entries submitted or the owner of an e-mail account shall be determined by Sponsor in its sole, reasonable discretion, and Sponsor reserves the right to disqualify any entries by persons determined to be tampering with or abusing any aspect of the Promotion.

PRIZES. Sponsor will choose, at random, one (1) contestant no more than 48 hours before each designated contest date. The one (1) contestant randomly selected will get four (4) game tickets to the designated

contest home game (seat selection determined by Sponsor in its sole discretion). Retail value of the tickets is \$120.00. Odds of being chosen as a winner of the tickets/contestant for the contest depends on the number of eligible entries received. The contestant chosen may not choose another person to participate on his/her behalf. Contestant must complete the "Contestant Agreement to Participate" prior to participating in the contest.

During the game, the contestant will have the chance to take one (1) shot through a target to win prizes including a new Toyota vehicle. The Toyota vehicle prizes include the 2025 Corolla Cross XLE, MSRP: \$29,560; the 2025 Camry XSE, MSRP: \$35,200; the 2025 Grand Highlander Hybrid XLE, MSRP: \$45,380; and the 2025 Tacoma TRD Sport, MSRP: \$39,800. The Prize Provider is allowed to substitute for prizes of equal or greater value. The depiction of the Prize Vehicle in any advertising or promotional materials or physical display may not reflect the actual vehicle delivered to the winner. Contestants shall not be permitted any practice, warm up or qualifying shots at any time after his/her notification of participation in the contest, nor will anyone contestant be selected to participate in this promotion on more than one occasion during the past 12 months. To determine which Toyota Branded Vehicle the winner will be shooting for, a computerized graphic will randomly select one of the eligible vehicles on the Replay Screen. Whichever vehicle is displayed will be the vehicle they could win. The list of prize vehicles is subject to change at Sponsor or Prize Provider's sole discretion. Details and amenities included with each vehicle are subject to Toyota's sole discretion.

The Contestant will not be permitted any practice, warm-up, or qualifying shots nor will any one (1) Contestant be selected to participate more than once during the promotion. The Contestant, using an NHL-regulation hockey stick, must attempt to hit one (1) NHL-regulation hockey puck (or one (1) of equivalent specifications) completely through the target hole ("Target Hole") in the target template that will be supplied by SCA ("Target Template"). From the moment control of the puck is released to the Contestant until Contestant's hockey stick last touches the puck, both the puck and Contestant must remain at least one-hundred and fifteen feet (115') from the Target Template behind the Blue Line furthest from the net. The Contestant will have one (1) attempt to successfully make one shot. An attempt has occurred when the puck leaves the Contestant's hockey stick in the direction of the Target Template, OR when the Contestant or puck come within one-hundred and fifteen feet (115') of the Target Hole in the Target Template. No blocking or grooving of the ice will be permitted. Puck cannot make contact with any surface or obstacle other than the hockey stick, ice, and Target Template once the puck has been hit by the Contestant. Banked shots are not allowed. The contestant will be eligible to win a prize in the event (i) the puck, traveling in a forward direction, passes completely through the Target Hole, prior to coming in contact with any object or person (other than the Target Template itself), and (ii) there is compliance with the terms and conditions of the contest rules. Contestant shall be responsible for any and all taxes, fees, insurance, registration, or other costs or expenses associated with acceptance of the prize. Contestant may not substitute cash.

The prize awarded will depend upon the number of successful attempts that pass completely through the Target Hole of the Target Template in compliance with the terms and conditions of the contest and all applicable rules. Prizes awarded shall be: for zero (0) successful attempts, four tickets to a future Winterhawks game, retail value of \$120; for one (1) successful attempt, the new Toyota Branded Vehicle determined prior to the contest with a retail value listed before that is determined based upon the vehicle won. If the contestant is a current Portland Winterhawks season ticket or ticket package holder, the retail

value of any tickets won may not be applied to any past, current, or future balance owed for their existing season tickets or ticket package(s).

WINNER NOTIFICATION AND ACCEPTANCE. The contestant/winner of the game tickets will be notified by telephone. If Sponsor is unable to reach the randomly chosen contestant in a timely fashion, as determined by Sponsor in its sole discretion, Sponsor will choose another contestant/winner of game tickets by random drawing. The contestant/winner may waive his/her right to receive a prize. Prizes are not assignable and nontransferable. No substitutions allowed, except that prizes and individual components of prize packages are subject to availability and Sponsor and Prize Provider reserve the right to substitute prizes of equal or greater value. The contestant/winner is solely responsible for reporting and payment of any federal, state, local, and municipal taxes on prizes and for payment of all expenses associated with the game other than game tickets, such as, but not limited to, parking. The contestant chosen to attempt the shot will be required to complete an affidavit of eligibility, and a liability and publicity release (except where prohibited by law) before attempting the shot. The contestant will also be required to complete the "Contestant Agreement to Participate" provided by Sponsor's prize indemnifier before attempting the shot. Failure to sign and return the affidavit or release or the Contestant Agreement to Participate, or to comply with any term or condition of these Official Rules, may, at the sole discretion of Sponsor, result in disqualification and the forfeiture of his or her interest in the prize. Except where prohibited, participation in the Promotion constitutes the winner's consent to the publication, dissemination and use of his or her name, photograph, image, likeness and voice by Sponsor, Prize Provider, SCA Promotions, their designees, and/or the Western Hockey League and its Member Teams in any media at any time for any purpose without any additional compensation to, permission from or inspection by the winner. If the contestant makes the shot, the contestant agrees to execute all necessary and requested documents, including without limitation the "Winner's Affidavit and Release", as requested by Sponsor and/or Prize Provider and Sponsor's prize indemnifier and agree to provide a copy of a government issued identification card containing a photo of the winner.

PARTICIPATION. By participating and/or accepting the prize, the contestant/winner agrees to be bound by these Official Rules and the decisions of Sponsor, Prize Provider and SCA Promotions. By entering, the contestant/winner further agrees to be bound by the terms relating to the use of this website, including its Privacy Policy. Sponsor reserves the right to disqualify persons found tampering with or otherwise abusing any aspect of this Promotion as solely determined by Sponsor. In the event the Promotion is compromised by a virus, non-authorized human intervention, tampering or other causes beyond the reasonable control of Sponsor which corrupts or impairs the administration, security, fairness or proper operation of the Promotion, Sponsor reserves the right in its sole discretion to suspend, modify or terminate the Promotion. Should the Promotion be terminated prior to the stated expiration date, Sponsor reserves the right to award prizes based on the entries received before the termination date.

LIMITATIONS OF LIABILITY. By entering the Promotion and accepting the prize, the contestant/winner agrees that (1) any and all disputes, claims, and causes of action arising out of or in connection with the Promotion, or any prizes awarded, shall be resolved individually without resort to any form of class action; (2) any claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including

costs associated with entering the Promotion, but in no event attorney's fees; and (3) under no circumstances will the contestant/winner be permitted to obtain any award for, and the contestant/winner hereby waives all rights to claim, punitive, incidental or consequential damages and any and all rights to have damages multiplied or otherwise increased and any other damages, other than damages for actual out-of-pocket expenses.

CONSTRUCTION. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the winner and Prize Provider and the Portland Winterhawks, shall be governed by, and construed in accordance with the laws of the State of Oregon, without giving effect to any choice of law or conflict of law rules or provisions (whether of Oregon, or any other jurisdiction) that would cause the application of the laws of any jurisdiction other than Oregon. The invalidity or unenforceability of any provision of these rules shall not affect the invalidity or unenforceability of any other provision. In the event that any such provision is determined to be invalid or otherwise unenforceable, these rules shall be construed in accordance with their terms as if the invalid or unenforceable provision was not contained therein. Contestant agrees that should any dispute arise between contestant and Sponsor's prize indemnifier, such dispute must be submitted to binding arbitration in accordance with the rules of the American Arbitration Association. The venue for such arbitration shall be Portland, Oregon.

WINNER RELEASES. By entering the Promotion and accepting the prize, the contestant/winner releases Toyota Motor Sales U.S.A., Inc., the Pacific Northwest Toyota Dealers Association, Portland Winterhawks, Inc., the Western Hockey League and its Member Teams, any other promotional sponsors, and each of their respective affiliated companies, and subsidiaries, directors, officers, employees, representatives, partners and agents from any liability whatsoever for any claims, costs, injuries, losses or damages of any kind arising out of or in connection with the Promotion or with the acceptance, possession or use of any prize (including, without limitation, claims, costs, injuries, losses or damages related to personal injuries, death, damage to, loss or destruction of property, rights of publicity or privacy, defamation or portrayal in a false light) .
